INDIGENOUS NATIONS IT'S TIME FOR NO MORE MISSING WOMEN AND CHILDREN

Enhancing Public Safety for Indigenous Nations THROUGH SWARM TACTICS

Public safety within Indigenous communities has long been a critical issue, particularly regarding the alarming rates at which women and children go missing. 
LEVERAGING LOCAL KNOWLEDGE AND RESOURCES

Volunteers who know the area's geography, hidden trails, and cultural landmarks can lead searches, making the process faster and more efficient. This localized approach not only enhances effectiveness but also fosters community engagement and empowerment.




REAL-TIME COORDINATION THROUGH TECHNOLOGY

Swarm tactics are greatly enhanced by technology, particularly using smartphones, GPS, and real-time communication platforms. **Deputize America's - Swarm Response System™** is a crowd-sourcing public safety system that uses a mobile app to allow community members to report sightings, share locations, and receive updates on the search efforts. This real-time data sharing creates a dynamic map of activities, allowing for better coordination and resource allocation. The very presence of a coordinated, community-driven safety effort can act as a deterrent to those who might harm or abduct women and children. Knowing that any incident will be met with a swift, organized response makes potential criminals less likely to act. Furthermore, the increased visibility that comes with swarming efforts—where many people are out searching and communicating—means that suspicious activity is more likely to be noticed and reported before it escalates. This proactive deterrence is a powerful tool in reducing the number of missing persons cases.
